I. Aditi Gupta, Proprietor of M/s Aditi Agarwal & Associates, Company Secretaries, New Delhi, was appointed as Scrutinizer for conducting Postal Ballot process through remote e-voting in respect of business contained in the Postal Ballot Notice dated February 25, 2025 ('Postal Ballot Notice') issued by the Company in electronic form to its members, whose e-mails registered with the Company or with the Depository Participant/Depository, for the purpose of scrutinizing the remote e-voting process in a fair and transparent manner and ascertaining the requisite majority on remote e-voting carried out as per the provisions of Section 108 & 110 of the Companies Act, 2013 ('Act') read with Rule 20 & 22 of the Companies (Management and Administration) Rules, 2014 ('Rules'), Regulation 44 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 ("Listing Regulations") read with SEBI Master Circular dated November 11, 2024, Secretarial Standard on General Meetings ('SS-2') issued by the Institute of Company Secretaries of India (ICSI), each as amended and other applicable laws and regulations read with General Circular Nos, 14/2020 dated April 8, 2020, 17/2020 dated April 13, 2020 and subsequent circulars issued in this regard, the latest being 09/2024 dated September 19, 2024, issued by the Ministry of Corporate Affairs ('MCA') (collectively the 'MCA Circulars') from time to time, on the resolutions referred in this report, which are proposed to be passed by the Members of Zuari Industries Limited ('the Company') through Postal Ballot only by electronic voting ('remote e-voting').

The management of the Company is responsible to ensure the compliance with the requirements of the Companies Act, 2013 and Rules relating to voting through electronic means (remote e-voting) on the resolutions contained in the Postal Ballot Notice as sent to the members of the Company. My responsibility as a scrutinizer for the remote e-voting process is restricted to make a Scrutinizer's Report of the votes cast in "favor" or "against" the resolutions stated below, based on the reports generated from the electronic voting system provided by the service provider agency, National Securities Depositories Limited ('NSDL') the authorized agency to provide remote e-voting facility, engaged by the Company.

We submit our report as under:

- 1. The remote e-voting platform remained opened from 09:00 A.M. IST on Wednesday, February 26, 2025 upto 5:00 P.M. IST on Thursday, March 27, 2025.
- 2. The Shareholders holding shares as on the cut-off date, i.e. Friday, February 21, 2025 were entitled to vote on the proposed 02 (Two) resolutions as mentioned in the Postal Ballot Notice dated February 25, 2025 of the Company.
- 3. On completion of voting at the Meeting, NSDL provided us with the list of members who had cast their votes, with their holding details and details of vote on each of the resolutions.
- 4. The votes were reconciled with the records maintained by the Company and RTA.
- 5. The results of remote e-voting were unblocked on the NSDL e-voting platform in the presence of two witnesses, namely, Ms. Kumkum Sharma and Mr. Harsh Bhatnagar, who are not in employment of the Company. They have signed in below in confirmation of the votes being unlocked in their presence.
